RULES AND REGULATIONS

No. 24 . . Extension of Service

For a period of five (5) years after construction of the extension, each additional customer whose service line is directly connected to the extension installed, and not to the extensions or laterals therefrom, shall be required to contribute to the cost of the extension based on a recomputation of both the utility's portion of the total cost and the amount contributed by the customers. The utility shall refund to those customers that have previously contributed to the cost of the extension that amount necessary to reduce their contribution to the currently calculated amount for each customer connected to the extension. All customers directly connected to the extension for a five (5) year period after it is placed in service shall contribute equally to the cost of construction of the extension. In addition, each customer shall pay the approved tap-on fee applicable at the time of his application for the meter connection. The tap-on fee shall not be considered part of the refundable cost of the extension and may be charged during the refund period. After the five (5) year refund period expires, any additional customer shall be connected to the extension for the amount of the approved tap-on fee only. After the five (5) year refund period expires, the utility shall be required to make refunds for an additional five (5) year period in accordance with subparagraph 1 of this paragraph.

This letter is to inform you that the South Anderson Water District will be serving Willow Creek Road located eight (8) miles off of US 62 West, Anderson County, Kentucky.


This service will be provided by a six (6) inch water main extended off of US 62 West, and will run eight thousand and seventy (8,070) feet of new four (4) inch water line.
