COMPLAINT

The complaint of James and Patricia Olson respectfully shows:

- (a) James and Patricia Olson 100 South Hill Versailles, Kentucky 40383
- (b) South Woodford Water District 460 Wilson Avenue Versailles, Kentucky 40383
- (c) That Mr. and Mrs. Olson extended an existing water main which was located approximately thirty (30) feet from the north border of their property, across their property, paralleling the west side of Carpenter Pike for a distance of 6,140 feet. The cost of the water line extension exceeded \$35,000.00. The water line extension was approved by the South Woodford Water District, Woodford County, Kentucky.

Since Mr. and Mrs. Olson installed the water main extension running north to south on Carpenter Pike, a person by the name of Andy Martin came onto the Olson property without an easement and tapped onto the water main extension

provided by Mr. and Mrs. Olson. Mr. Martin has refused to pay for his tap-on to the Olson water main extension. Mr. Martin also has future plans for other hook-ups to the Olson's water source.

Another neighbor, Renald McDenald, also has property on the east side of Carpenter Pike. Mr. McDenald intends to tap-on to the Olson water main extension for the purpose of serving his own property and a twenty-three (23) lot subdivision which he intends to develop, and for which he has already received a zone change.

Mr. Clifford McDonald, yet another neighbor, has already been allowed to tap-on to the Olson's extension, but payment from Clifford McDonald was made to the South Woodford Water District.

Finally, Mr. and Mrs. Olson have not been reimbursed by the South Woodford Water District or by any of the before mentioned neighbors for any of their intrusive acts.

wherefore, complainants ask that the cost of the water main in question be distributed amongst those who plan to utilize it according to 807 KAR 5:066 sec. 11(2)(b)(2). In the alternative, complainants ask that the cost of the water main in question be distributed amongst those who plan to utilize it according to 807 KAR 5:066 sec. 11(2)(b)(3).
