## <u>O R D E R</u>

On February 1, 1996, and May 1, 1996, the Commission issued its Orders in Case Nos. 90-342-S and 90-342-T, respectively. These Orders removed storage costs from the Expected Gas Cost ("EGC") portion of the Gas Cost Adjustment ("GCA") rates of Delta Natural Gas Company, Inc. ("Delta") pending the Commission's decision regarding the proposed storage rate from Deltran, Inc. ("Deltran".) On May 9, 1996, the Commission approved Deltran's proposed tariff, including rules and regulations for gas storage service.<sup>1</sup> The fee for such service was effective May 1, 1996, pursuant to a Deltran tariff revision filed with the Commission on March 29, 1996.

The Commission finds that Delta's EGC filed March 29, 1996, should be included in Delta's GCA rates for the remainder of the calendar quarter beginning May 1, 1996, pursuant to the Commission's approval of the Deltran tariff. Delta's approved EGC should be \$3.3769 per Mcf, with the resulting gas cost recovery

("GCR") rate of \$3.6922. Any discrepancies in collections resulting from the May 1, 1996 effective date of the Deltran fee and the effective date of the rates contained in the Appendix to this Order may be included for recovery in a future actual adjustment component of Delta's GCA filing.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for final meter readings on and after the date of this Order.

2. Within 30 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
