ORDER

On December 17, 1993, in Case No. 93-400, the Commission approved the merger of Elzie Neeley Gas Company, Inc. ("Elzie Neeley") and Phelps Gas Company, Inc. ("Phelps") into Mike Little Gas Company, Inc. ("Mike Little") and provided for the adjustment of rates of the merged companies on a quarterly basis in accordance with the provisions of Mike Little's gas cost adjustment ("GCA") clause.

On October 2, 1996, Mike Little filed its GCA to be effective November 1, 1996 until January 31, 1997.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Mike Little's notice proposed revised rates designed to pass on its expected wholesale increase in gas cost to its customers. Mike Little's expected gas cost ("EGC") for the quarter is \$4.4875 per Mcf.
- 2. Mike Little's notice neglected to set out a previous quarter refund adjustment ("RA") of .12 cent per Mcf. The total RA is .12 cent per Mcf.
- 3. Mike Little's notice set out a current quarter actual adjustment ("AA") of (.84) cent per Mcf to return over-recovered gas cost from May, June, and July 1996. The total

AA of (12.63) cents per Mcf reflects the net over-recovery of the combined system for the current and previous three quarters.

- These adjustments produce a gas cost recovery rate ("GCR") of \$4.3600 per 4. Mcf, 66.39 cents per Mcf more than the prior rate.
- The rate adjustments in the Appendix to this Order are fair, just, and 5. reasonable, in the public interest, and should be effective for gas supplied on and after November 1, 1996.

IT IS THEREFORE ORDERED that:

- The rates in the Appendix, attached hereto and incorporated herein, are fair, 1. just, and reasonable and are effective for gas supplied on and after November 1, 1996.
- Within 30 days of the date of this Order, Mike Little shall file with the 2. Commission its revised tariffs setting out the rates authorized in this Order.
