O R D E R

On March 14, 1995, the Commission entered an Order setting forth findings of fact on Kentucky-American Water Company's ("Kentucky-American") demand projections and sources of supply and terminated this investigation. The Commission subsequently granted Kentucky-American's petition for rehearing to the limited extent that this investigation would remain open to await a new safe-yield analysis of the Kentucky River.

On October 7, 1996, the Kentucky River Authority ("KRA") filed a copy of the final draft of the Kentucky River Basin Water Supply Assessment Study ("1996 Kentucky River Study") compiled by the Kentucky Water Resources Research Institute. Kentucky-American now requests the Commission to schedule a hearing on the 1996 Kentucky River Study. Based on the motion and the responses thereto, the Commission finds that further proceedings are appropriate and necessary and a procedural schedule should be adopted.

IT IS THEREFORE ORDERED that:

1. The 1996 Kentucky River Study is a part of the record in this case and is deemed to be the prefiled direct testimony of the KRA.


2. The procedural schedule set forth in Appendix A, attached hereto and incorporated herein by reference, shall be followed in this case.

3. Copies of all documents filed with the Commission shall be served on all parties of record.

4. Each response to a request for information shall include the name of the witness who will be available at the hearing to testify on that subject matter.
