ORDER

On March 28, 1996, Ohio County Water District ("Ohio Water") filed an application seeking authority to assume ownership of the Rough River Water System, Inc., to adjust its rates, and to increase its connection fees. Because the application seeks a rate adjustment, this case was placed on the docket as a general rate case.

General rate cases are governed by KRS 278.190. KRS 278.190(3) states, inter alia, that the Commission shall decide such cases "as speedily as possible, and in any event not later than ten (10) months after the filing of such schedules." The Commission's goal is to decide such cases within a 5-month period.

On April 30, 1996, the Commission entered an Order requiring Ohio Water to provide additional information by no later than May 14, 1996. On May 15, 1996, Ohio Water requested an extension of time up to and including July 15, 1996 within which to provide the information. The Commission granted the extension.

By statute, the Commission's final decision in this case must be entered by no later than January 28, 1997. The Commission's goal however was to enter its final order by no later than August 28, 1996. By granting Ohio Water's May 15, 1996 request, the Commission realized the impossibility of achieving its goal. At that time, its concern shifted from the 5-month goal to the 10-month statutory deadline.

On July 15, 1996, Ohio Water filed its Second Motion For Extension Of Time To Comply With "Attorney General's Request For Information" And With PSC "Order" ("Motion"). In its Motion, Ohio Water seeks an extension of time up to and including July 25, 1996 to provide the requested information. As grounds for the Motion, Ohio Water states that the volume of work required and the delays created by vacation schedules, sickness and other day-to-day tasks of the parties involved made it impossible for Ohio Water to fully comply with the Commission's Order.

Good cause having been shown, the Commission finds that Ohio Water's motion should be granted. However, Ohio Water should be advised that the Commission will closely scrutinize any future requests for extensions to ensure that ample time remains to process this case within the 10-month statutory period.

IT IS THEREFORE ORDERED that:

Ohio Water's motion for an extension of time up to and including July 25,
 1996 to provide its responses to the Commission's April 30, 1996 Order is hereby granted.

2. The revised procedural schedule attached as an Appendix to this Order shall be followed by all parties to this case.
