Dear Mr. Mills:

We are writing to object to the issuance of a Certificate of Public Convenience for the construction of the Sprint Spectrum/Wirelessco, L.P. (Sprint Spectrum) Personal Communication Services tower and facility at 11208 Covered Bridge Road, Prospect, Kentucky in Oldham County listed as case # 96-227.

We would like this letter to serve as notification of a request for intervenor status for the above mentioned case number.

Because the notification of this planned construction was not made to us directly by Sprint Spectrum, but rather indirectly by the Oldham County Planning and Zoning Commission, we have not had sufficient time to acquire all of the details of the proposed tower, much less evaluate its ramifications to the area.

Nevertheless, based on what we know so far, we request intervenor status based on the following:


- Despite the fact that the Kentucky legislature blocked Planning and Zoning authority over Public Service Commission issues, this is commercial/industrial construction in an area that is still zoned agricultural and conservation and is settled as a residential area.
- We believe that collocation and neighborhood impact reduction strategies need further consideration.
- We do not believe that this PCS system is a "necessity" as stated in item # 11 of the application.
- We object to the devaluation of this and the surrounding property.

- We object to the despoiling of the visual value of one of the more unique, picturesque, and historic areas of Oldham County.
- We object to sharing our 3/4 mile long single lane gravel drive with the construction traffic, being forced to tolerate the noise and dust during the construction and maintenance, and to the stress upon and endangerment to the horses which are unfenced along the drive.


We may wish to expand the list of objections later after we have had time to further study the situation.

Dear Tom:

I learned yesterday of the proposed building of a 265' telecommunications tower on your property. I would like to go on record expressing my concerns regarding this structure. My property is less than one-half mile from this proposed structure.

First, our neighborhood is an agricultural/residential area. The tower would be of a light industrial nature, not in keeping with our current setting. Second, I feel the height of the tower may pose a safety risk to the small aircraft which utilize our airspace as a practice site. Third, the Covered Bridge Road corridor, encompassing Sleepy Hollow, is a wonderfully historic site, with early settlement activity dating back over two hundred years.

My hopes would be that we could continue to preserve the important historical value of our neighborhood for future generations. A 265' telecommunications tower is obviously not in keeping with this goal.

Thank you for your consideration of these concerns. I hope we can continue to foster a well-knit neighborhood relationship which benefits everyone now, and in the future as well.
