## ORDER

On June 13, 1996, Sprint Spectrum, L.P., on behalf of WirelessCo, L.P., ("WirelessCo"), a utility authorized to provide personal communications services by Commission Order dated April 23, 1996, filed an application for a certificate of public convenience and necessity to construct a personal communications services facility on Covered Bridge Road, Prospect, Oldham County, Kentucky.

Several property owners in the vicinity, citing, inter alia, concerns that the proposed location is inappropriate for a telecommunications tower, have objected to the proposed facility and have been granted intervention in this proceeding. Kent Kalmey, who was granted intervention on July 17, 1996, requested a hearing on this matter. The Commission held the motion in abeyance until such time as all who had an interest in this matter had had sufficient opportunity to request intervention. No further intervention requests have been received since Mr. Kalmey was granted intervention. Consequently, it appears that the motion for hearing should now be addressed.

The Commission being sufficiently advised, IT IS THEREFORE ORDERED that:

1. A hearing on the proposed facility is scheduled for September 19, 1996, at

10 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 730

Schenkel Lane, Frankfort, Kentucky.

2. WirelessCo shall appear at the hearing and be prepared to present testimony

on the engineering design, location, and construction of the facility, and all other issues

raised by the intervenors.

3. Within 20 days of the date of this Order, each party shall file a list of its

witnesses who will testify at the hearing together with a brief description of those matters

to which each witness will testify.

4. Any interested person shall have the opportunity to present testimony or

comment on any aspect of the proposed facility.

5. Pursuant to KRS 100.324, a copy of this Order is being sent to the Oldham

County Planning and Zoning Commission for the purpose of notification that the above-

scheduled hearing may affect locations or relocations of service facilities within the planning

unit's jurisdiction.
