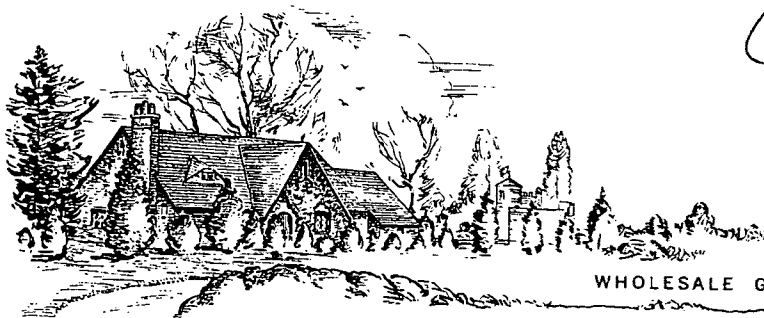
I protest and request intervention in this proposal.
