O R D E R

The Commission has received the attached letters from Ruth Klingenfus and Ricky Schaaf regarding the proposed cellular telecommunications facility to be located at 6384 LaGrange Road (Highway 146), Crestwood, Jefferson County, Kentucky. Mr. Schaaf's letter was also signed by five residents of Clore Avenue. For purposes of this Order, the Commission designates Ricky Schaaf as spokesperson for the Clore Avenue residents.

IT IS THEREFORE ORDERED that:


1. Kentucky CGSA, Inc. ("Kentucky CGSA") shall respond to Ms. Klingenfus's and Mr. Schaaf's concerns by certified letter, within 10 days of the date of this Order.
2. Kentucky CGSA shall file a copy of the certified letter and dated receipt, within 7 days of the date on the receipt.

Dear Mr. Mc Namara,

I am writing to comment on the proposed tower. I was the first person contacted about having this tower on my property and I refused it. I am a senior citizen (living on a fixed income who could surely use the money), but I think this unsightly tower is not in keeping with our neighborhood and that it will cheapen my property value. Others in neighborhood also refused.

I can't imagine that in order to build a 190' structure you only have to notify people owning property within a 500' radius. I know many people use cellular phones and these towers are necessary. Possibly you could look into co-locating these towers where these ~~existing~~ antennas could be located on existing structures as the tower in Brownsboro or water towers.

I live across the street from three schools and have many students crossing through my yard. I can just imagine the lure to these kids to climb this tower. I have enough problem with these trespassers now and I don't

need anything else to attract them to this area.

I have also been told that having a cellular tower close to your house causes interference and static on television sets.

I feel sure that you would not want one of these towers close to your house any more than I do.

In regards to the case # 96-286, the residents and I of Clore Ave., Crestwood, Ky. are opposed to the location and building of the cellular radio tower. We don't oppose towers, but the location of this tower is not in the best interest of the public, especially in regards of safety. The location of this tower is directly across from the main entrance of the South Oldham Middle and Camden Station Elementary. This tower will also be built close to the railroad tracks on which trains travel up to 45 m.p.h. and also one of the most heavily traveled road in the county.

If something were to happen to this tower, due to train derailment, storm, or other outside forces, this tower would land possibly on motorist, railroad tracks, or even school buses or our children. Also there are several business buildings at this location.

Please reconsider the building of a tower at this location and find a more suitable site. Perhaps a location that would not pose as many safety concerns for our school children and the community around it.
