- 5) Has an application for the erection of the proposed antenna been filed with the Louisville and Jefferson County Planning and Zoning Commission? If so, what is the docket number?
- 6) Provide a copy of the written statement from the Louisville and Jefferson County Riverport Authority that the proposed antenna is in compliance with the Deed Restrictions (Deed Book 5299 Page 198 Paragraph 6.3).

Biltco Corporation is opposed to the erection of this antenna for the following reasons:

- a) The electrical and communication systems at our new location could be adversely affected because of the proximity of the antenna.
- b) In our opinion, The Louisville and Jefferson County Riverport Authority did not intend to allow individual property owners to decide where to locate permanent utility systems.
- c) In our opinion, the antenna does not meet the requirements or the intent of the Deed Restrictions established for this industrial park.
- d) In our opinion, the antenna may pose a hazard to our building and personnel.
- e) In our opinion, the antenna will be unsightly.
- f) In our opinion, the antenna location will affect our property values negatively.
