Dear Mr. Mills:

I am a resident of Countryside subdivision in Oldham County, Kentucky. It has come to my attention recently that Wirelessco, L.P., on behalf of Sprint, has filed application with the Public Service Commission to construct and locate a 193 foot monopole within 500 feet of our subdivision. Several of our residents whose properties are within this 500 foot radius have been contacted in writing by the PSC notifying them of Sprint's intention of building this monopole, and they have responded negatively.

Please be advised that I am adamantly opposed to the construction of this tower. I did not move into Oldham County for its commercialization aspects. I moved into this county for the beauty of the trees and the open spaces and the pastures and being able to stand on my back deck and look over on a ridge overlooking Rte. 329 and seeing deer on that ridge, and listen to the cows mooing in the morning and at night on property located behind me.

Please consider these thoughts, along with the thoughts of my neighbors and schedule a public hearing so our opinions and concerns can be heard before more of our beautiful land is destroyed with ugly towers that will devalue our homes and possibly cause us to be subjected to uncertain levels of electromagnetic fields and fallout.

Dear Mr. Mills:


My home is within 500 feet of this proposed project, and the proponents have chosen to avoid notifying me and others of its application.

I wish to voice my strong opposition to the erection of this 193 foot "monopole" in our community for the following reasons:
