O R D E R

On October 8, **1996**, the Commission established a procedural schedule in this matter. Finding that changes are required in that schedule, the Commission **HEREBY ORDERS** that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed. To the extent that conflicts exist between this procedural schedule and previous procedural schedules, this procedural schedule shall control.

2. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and **10** copies to the Commission.

3. The Municipal Water System of the City of Hodgenville, Kentucky ("Hodgenville") shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.

4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
