Dear Mr. Mills:

I received your notice of the proposed tower at 737 Petersburg Road, Hebron, Kentucky. This site is directly across the street from another tower, which was installed several years ago. This referenced tower was originally proposed at approximately 200 feet but was substantially reduced in size by the FAA (less than 100 feet) since the Cincinnati/Northern Kentucky International Airport is located very close to this site.

We have received many notices recently for proposed towers to be located near the airport. These towers are of major concern to us since these could limit our ability to operate as a major airport. We have lodged letters of concern with the Kentucky Aeronautical Zoning Commission.

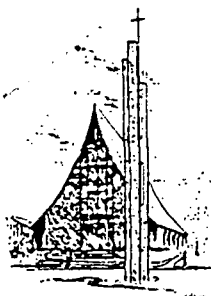
Please accept this letter as our formal objection to the installation of any tall towers, which could affect the operation of Cincinnati/Northern Kentucky International Airport.

Dear Commission Members:

I am writing on behalf of Hebron Lutheran Church with a question about GTE Mobilnet's application to construct a 135' antenna tower on Hebron Fire Department property which is adjacent to church owned property (Case No. 96-425). The chief concern and question is whether or not this will cause static or interference with the church's sound system and electronic equipment, which includes wireless microphones. A second concern seems possibly to be answered by the description of the tower as "self supporting." Assuming this means there will be no guy-wires necessary, none would be required on the church owned property which we intend to use for future expansion. Would this tower in any way hamper our using that property for future expansion?

Thank you for addressing these concerns.
