O R D E R


It appears that the parties hereto remain unable to reach protective agreements so that all parties may attend the informal conference scheduled to discuss the cost studies filed by GTE South Incorporated ("GTE South") which are relevant to these proceedings. Furthermore, it appears that meaningful participation in these proceedings will be denied to parties who are denied access to the cost studies for which confidentiality is claimed. 807 KAR 5:001, Section 7(5)(b).

As the parties are well aware, the Telecommunications Act of 1996 imposes strict time constraints upon these proceedings. It also requires the parties to negotiate in good faith. The Commission should not be required to referee each and every disagreement that arises among the parties. However, scheduling difficulties mandate that this conference take place today if at all possible.




