IT IS WITHIN 12-15 FT OF PROPOSED STRUCTURES. NOT ONLY WILL THESE STRUCTURES BE UNSIGHTLY, BUT I AM CONCERNED ABOUT THE HEALTH HAZARDS THAT MAY AFFECT OUR CHILDREN AND WILDLIFE. THE RESIDENTS OF HARBOR VILLAGE HAS REQUESTED CURRENT STUDIES FROM THE KY. DEPT. OF CANCER EPIDEMIOLOGY THAT MAY SHOW A DIRECT LINK BETWEEN THE ELECTRO MAGNETIC ENERGY PRODUCED FROM THESE SUB-STATIONS TO CANCER. ALSO WE WOULD LIKE A MEETING WITH KY. UTILITIES TO DISCUSS ANY ~~AND~~ INFO. AND/OR STUDIES THEY MAY HAVE ABOUT LINKS BETWEEN ELECTRO MAGNETIC ENERGY AND CANCER.
