ORDER

On September 26, 1996, in Administrative Case No. 355,¹ the Commission discussed at length its preliminary findings regarding universal service issues. The Commission stated its intent to conduct workshops to determine the best methods of handling the details of implementing the Universal Service Fund in Kentucky. The workshops were to address issues such as (1) defining "rural" and "urban" customers and determining the level of support necessary for each group, (2) determining appropriate parameters for local service territories, (3) monitoring the effectiveness of low income assistance programs, and (4) determining the method of fund administration.

However, since the time the Commission entered its Order, the telecommunications landscape has changed. Arbitration and negotiation have produced interconnection agreements which open the way for selective service through fiber rings and other means to be available to large business customers, but not to low-volume customers. Such a result conflicts with the Commission's initial determination in its September 26, 1996 Order that competing services should be available to all customers within a given area. Moreover, the Federal Communications Commission ("FCC") will

shortly enter orders regarding universal service and access charge restructuring which are expected to have great impact upon this Commission's review. Accordingly, the troubling specter of cherry-picking, as well as the ramifications of relevant FCC orders, will be central issues in this proceeding, and should be examined in a more formal manner than that originally planned.

Therefore, the Commission finds that the following procedural schedule, which includes a public hearing, is reasonable and will be more expeditious than the workshop process initially planned.
