O R D E R

The first meeting of the Collaborative Forum ("Collaborative") took place October 16, 1997. The Commission is advised that one member's name was inadvertently omitted from the Collaborative's membership list, attached as Appendix D to the Commission's October 9, 1997 Order. In addition, Columbia Energy Services has replaced its originally proposed representative.

Since the meeting's conclusion several Collaborative members, and numerous others who were in attendance at the meeting and participated in the discussion, have requested that the allotted time for the remaining two meetings be expanded. In this way more time will be available to pursue the issues which need to be discussed. It has also been suggested to the Commission that Collaborative members should file information which documents and clarifies their issues and concerns regarding natural gas unbundling and residential customer choice. The Commission concurs and encourages each Collaborative member to do so.

The Commission, on its own motion, HEREBY ORDERS that:

1. The Collaborative's membership list is revised to reflect the addition of David Brown Kinloch, whose name was inadvertently omitted in the initial list, and Jim Doult, who replaced Columbia Energy Services' previously named representative.

2. The revised meeting time for the remaining Collaborative's meetings, scheduled November 6, 1997 and December 4, 1997, is 9:00 a.m. - 2:00 p.m. EST.


3. Any Collaborative members choosing to file information clarifying their individual issues and concerns shall file an original and 10 copies with the Commission, with a copy to all parties of record no later than December 1, 1997.

ORDER

2. The KAPHCC shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should the KAPHCC file documents of any kind with the Commission in the course of these proceedings, it shall also serve a copy of said documents on all other parties of record.
