## ORDER

This matter arising upon the motions of Janie Johnson, Talton InVision, Inc., and the Kentucky Department of Corrections (hereinafter referred to collectively as "Petitioners") for full intervention, and it appearing to the Commission that Petitioners have a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings, the motions of Petitioners should be granted.

This matter further arising upon the motions of the Kentucky Department of Corrections ("Department of Corrections"), BellSouth Telecommunications, Inc. ("BellSouth") and BellSouth Public Communications, Inc. ("BellSouth Public") for extension of time and for continuance of this hearing, and it appearing to the Commission that a delay may assist in the development of this proceeding, and the delay sought is not unreasonable, the motions of the Department of Corrections, BellSouth, and BellSouth Public should be granted.

The Commission having considered the motions and being otherwise sufficiently advised, HEREBY ORDERS that:

1. The motions of Petitioners to intervene are granted.

2. Each Petitioner shall be entitled to the full rights of a party and shall be served

with the Commission's Orders and with filed testimony, exhibits, pleadings,

correspondence, and all other documents submitted by parties after the date of this Order.

3. Should any Petitioner file documents of any kind with the Commission in the

course of these proceedings, said Petitioner shall also serve a copy of said documents on

all other parties of record.

4. The motions for extension of time and continuance of the hearing are granted.

5. Telecommunications carriers desiring to participate in this proceeding shall

move to intervene by no later than January 5, 1998.

6. Interested persons may file comments on this Order, which will be considered

prefiled testimony, by no later than January 28, 1998.

7. The December 9, 1997 informal conference shall be rescheduled to March

3, 1998 at 9:00 a.m., Eastern Standard Time, in Conference Room 1 of the Commission's

offices at 730 Schenkel Lane, Frankfort, Kentucky.

8. The December 18, 1997 hearing shall be rescheduled to March 26, 1998, at

9:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 730

Schenkel Lane, Frankfort, Kentucky.
