ORDER

Kentucky Industrial Utility Customers, Inc. ("KIUC") has moved for an Order to compel Kentucky Utilities Company ("KU") to respond to certain information requests and for modifications to the procedural schedule. The Attorney General ("AG") has also moved for modifications to the procedural schedule. Having reviewed the motions and responses thereto, the Commission grants KIUC's motion in part and denies in part. It denies the AG's motion.

The Commission expects all parties to act in a professional manner and to comply with the Commission's procedural orders. It advises the parties that disputes regarding discovery issues should be resolved informally whenever possible. All parties are expected to timely review responses to discovery requests and, if a response is deemed unresponsive, to promptly request the opposing party's compliance. The Commission further expects that reasonable requests for compliance will be promptly met. Where parties are unable to resolve their differences, a timely motion to compel is then appropriate. IT IS THEREFORE ORDERED that:

1. KIUC's motion to compel further responses to KIUC Request Items 2, 3, 4(e), 19(a), 26, and 27 is denied.

2. KIUC's motion to compel further response to KIUC Request Item 24(c) is granted in part. KIUC shall select 10 transactions from the list contained in KU's Response to KIUC's Motion to Compel and shall advise KU in writing of its selection no later than 12:00 p.m., Eastern Time, on February 3, 1997. KU shall provide the requested information on the selected transactions no later than February 10, 1997. If KIUC prefers to conduct an onsite inspection of these documents, it shall advise KU of its preference in writing no later than 12:00 p.m., Eastern Time, on February 3, 1997. KU shall provide the selected transactions of these documents, it shall advise KU of its preference in writing no later than 12:00 p.m., Eastern Time, on February 3, 1997. KU shall make these documents available for inspection at its main offices during normal business hours at a date to be mutually agreed upon. The inspection shall occur no later than February 21, 1997, unless KIUC agrees to a later date.

4. KIUC and the AG's motions to modify the procedural schedule to extend by 30 days the time for the filing of intervenor testimony are denied. The testimony of intervenor witnesses shall be filed with the Commission no later than February 5, 1997.

5. If, after reviewing the additional information which KU has been ordered to produce, any intervenor wishes to supplement the filed testimony of its witnesses, it shall make a timely motion to supplement. Such motion shall include the proposed supplemental testimony. Motions filed with this Commission after March 3, 1997 will not be considered timely filed.

6, 1997 is vacated and replaced with the procedural schedule appended hereto.
