O R D E R

On August 13, 1997, a letter, which the Commission will treat as a motion, was filed by Holland N. McTyeire V, attorney for AT&T Communications of the South Central States ("AT&T"). The letter states the parties have agreed to a schedule of witnesses for the upcoming hearing and requests that the Commission adopt the parties' schedule, which specifies witnesses for each of the five days set aside for this hearing. The parties also request that, if necessary, the proceedings of Monday and Tuesday extend into the evening hours in order to ensure completion of the hearing at a reasonable time later in the week.

The Commission adopts the parties' schedule with one modification. Although no intervenor witnesses will be required to testify prior to Wednesday, August 27, 1997, the Commission will not necessarily conclude Wednesday's proceedings after the testimony of ACSI witness Riley Murphy on Wednesday, as the parties suggest. Nor will it necessarily conclude Thursday's proceedings after the testimony of AT&T witness Michael Pfau. Instead, beginning on Wednesday, intervenor witnesses should be prepared to testify in the order suggested by the parties. This modification of the parties'

proffered schedule will enable the Commission to conclude these proceedings as efficiently and expeditiously as possible.
