IT IS HEREBY ORDERED that:

1. The motion of Petitioners to intervene is granted.
2. Each Petitioner shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

Dear Mr. Mills:

The Lexington-Fayette Urban County Government (hereinafter referred to as LFUCG) wishes to state its concerns regarding the above-captioned amended application for a cellular tower and equipment shelter for property located at 3459 Buckhorn Drive. Additional information has been provided to us by Kentucky CGSA, Inc. and an initial review relative to the LFUCG's Cellular Tower site criteria has raised certain issues we wish addressed by the applicant. Further, the notice sent by the applicant to surrounding property owners has resulted in citizen inquiries to the LFUCG. I specifically request that either the PSC or the applicant address the following items as appropriate:


1. It appears that the 100% fall line, and perhaps the 60% fall line, would extend to single family residential property located on Smoky Mountain Drive and/or Mount Foraker Drive; as well as Berryhill Park. Berryhill is a public neighborhood park that contains a public bikeway/walkway adjacent to the lot on which the tower is proposed. The LFUCG wishes that the applicant comment on any potential problems arising from this proximity.
2. The LFUCG wishes to be provided with a map showing the maximum search ring for this proposed facility, so that it may have the ability to comment upon the applicant's contention that "...there is no other suitable location reasonably available..." as an alternative to the proposed site.
3. Addition of a condition by the PSC that the tower be removed if it ever ceases to be used as a cellular transmitting facility.
4. Information as to proposed screening/buffering of the proposed facilities from adjoining properties. The property abuts residential areas.
5. I would also note that this property is subject to a site development plan (copy attached),

and no permits can be issued for any development of this property unless and until an amendment to this development plan has been approved by the Planning Commission.

The LFUCG's Cellular Tower Committee will review any response received in the hope that concerns can be addressed short of requesting intervention. I am also sending a copy of this letter to Sam McNamara, attorney for Lexington MSA Limited Partnership.

The Lexington-Fayette Urban County Government looks forward to a response from the applicant and/or the Public Service Commission on these requests.

Dear Mr. Mills:

We, property owners and residents of the area surrounding 3459 Buckhorn Drive, do hereby strongly request to intervene on your plans to construct a cellular radio telecommunication facility. In your correspondence to us, you stated that the site is at the rear of an abandoned shopping center building. Does this make it any better? The abandoned building has been an eyesore for years and we do not appreciate this being an excuse to use the site as a dumping ground. The owner of this property has dragged his feet on cutting grass and general upkeep since he purchased the buildings. Why should he be the beneficiary of your rent payments? The building may be a distance from the main road (Buckhorn), however, it is in our backyards. We have several other concerns in addition to the sheer unsightliness of the proposed facility:

- 1) The fall line extends into single family residential property located on Smoky Mountain and Mount Foraker: as well as Berryhill Park. The park contains a public bikeway/walkway adjacent to the lot on which the tower is proposed.
- 2) There must be another suitable location.
- 3) Even though the property is not "in" a residential area, it is surrounded by one. We see this as an attempt to bend the intentions of the LFUCG's request to keep these towers out of residential neighborhoods.
- 4) It is near a child care center in Buckhorn Plaza.
- 5) They are: generally incompatible with residential areas, obtrusive, out of scale and character, and pose a safety threat.
