O R D E R

Taylor County Rural Electric Cooperative Corporation ("Taylor County") has applied for Commission approval to adjust its rates for service rendered on and after June 9, 1997. After reviewing the application, the Commission finds that further proceedings are necessary to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to June 9, 1997.

IT IS THEREFORE ORDERED that:

1. Taylor County's proposed rates are suspended for five months from June 9, 1997 to November 8, 1997.
2. The procedural schedule appended hereto shall be followed.
3. All requests for information and responses thereto shall be appropriately indexed and tabbed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.
4. Taylor County shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
