O R D E R

On June 26, 1997, Cumberland Cellular Partnership ("Cumberland Cellular") filed an application seeking a Certificate of Public Convenience and Necessity to build and operate a cellular radio telecommunications facility for Rural Service Area No. 5 ("RSA No. 5"). RSA No. 5 includes Adair, Barren, Clinton, Cumberland, Hart, McCreary, Metcalfe, Monroe, Russell, and Wayne counties. Cumberland Cellular has requested authorization to construct a cell site in Cumberland County. Cumberland Cellular was previously granted authority to operate a cellular radio telecommunications system in RSA No. 5 in Case No. 91-180.<sup>1</sup>

The proposed cell site consists of a 300-foot or less guyed antenna tower to be located at 1138 Jackson Hollow Road, Burkesville, Cumberland County, Kentucky ("the

Burkesville cell site"). The coordinates for the Burkesville cell site are North Latitude 36° 47' 20.2" by West Longitude 85° 22' 54.9".

Cumberland Cellular has provided information regarding the structure of the tower, safety measures, and antenna design criteria for the Burkesville cell site. Based upon the application, the design of the tower and foundation conforms to applicable nationally recognized building standards, and the plans have been certified by a Registered Professional Engineer.

Pursuant to KRS 100.324(1), the Burkesville cell site's construction is exempt from local zoning ordinances; however, Cumberland Cellular notified the Cumberland County Judge/Executive of the pending construction. Cumberland Cellular has filed applications with and received approvals from the Federal Aviation Administration and the Kentucky Airport Zoning Commission for the construction and operation of the Burkesville cell site.

Cumberland Cellular has filed notices verifying that each person who owns property or who resides within 500 feet of the Burkesville cell site has been notified of the pending construction. The notice solicited any comments and informed the property owners or residents of their right to intervene. In addition, notice was posted in a visible location on the proposed site for at least two weeks after Cumberland Cellular's application was filed. To date, no intervention requests have been received.

Pursuant to KRS 278.280, the Commission is required to determine proper practices to be observed when it finds, upon complaint or on its own motion, that the facilities of any utility subject to its jurisdiction are unreasonable, unsafe, improper, or insufficient. To assist the Commission in its efforts to comply with this mandate, Cumberland Cellular should notify the Commission if it does not use this antenna tower to provide cellular radio

telecommunications services in the manner set out in its application and this Order. Upon receipt of such notice, the Commission may, on its own motion, institute proceedings to consider the proper practices, including removal of the unused antenna tower, which should be observed by Cumberland Cellular.


The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that Cumberland Cellular should be granted a Certificate of Public Convenience and Necessity to construct and operate the Burkesville cell site in RSA No. 5 under its previously approved tariff.

IT IS THEREFORE ORDERED that:

1. Cumberland Cellular is granted a Certificate of Public Convenience and Necessity to construct and operate the Burkesville cell site.
2. Cumberland Cellular shall immediately notify the Commission in writing, if, after the antenna tower is built and utility service is commenced, the tower is not used for a period of 3 months in the manner authorized by this Order.
