O R D E R

(hereinafter referred to collectively as "Petitioners") for full intervention, and it appearing to the Commission that Petitioners have a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings, and this Commission being otherwise sufficiently advised,

IT IS HEREBY ORDERED that:

1. The motions of Petitioners to intervene are granted.
2. Each Petitioner shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Should any Petitioner file documents of any kind with the Commission in the course of these proceedings, said Petitioner shall also serve a copy of said documents on all other parties of record.

O R D E R

IT IS ORDERED that Green River Electric Corporation ("Green River") shall file the original and 8 copies of the following information with the Commission by December 31, 1997 with a copy to all parties of record. Each copy of the information requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure its legibility. Where the requested information has been provided along with the original application, in the format requested herein, reference may be made to the specific location of that information in responding to this Order. When applicable, the requested information should be provided for total company operations and jurisdictional operations, separately.

1. Refer to Green River's Response to the First Information Request of the Attorney General ("AG"), Item 38. Provide the following payroll information for each employee:

- a. The actual regular hours worked during the test year.
- b. The actual overtime hours worked during the test year.
- c. The test-year-end wage rate for each employee and the date of the last increase.
- d. A calculation of the percent of increase granted during the test year.

Green River shall identify all the employees as either salaried or hourly, and also as either full-time, part-time, or temporary. Employee numbers or other identifiers may be used instead of employee names. Include an explanation of how the overtime pay rate is determined. All employees terminated during the test year shall be identified (along with the month in which the termination occurred), as well as those employees who replaced terminated employees or were otherwise added to the payroll during the test year. If Green River has more than 100 employees, the above information may be provided by employee classification.

2. a. (1) Provide the base wages and salaries used to calculate payroll taxes.

(2) Explain how the base wages and salaries were determined.

b. Provide the payroll tax rates in effect at test-year-end.

3. Refer to Green River's Response to the AG's First Information Request, Item 61. Explain the increase of 43 percent in Outside Services Employed from 1995 to 1996.

4. Refer to Green River's Response to the AG's First Information Request, Item 61. Explain the \$13, 698.98 payment to Big Rivers in 1995 and 1996.

5. Refer to Green River's Response to the AG's First Information Request,
Item 63.

- a. Does the rate expense include any in-house labor?
- b. If yes, provide the amount.
