("YWCA"), filed June 12, 1998, for full intervention, and it appearing to the Commission that the YWCA has a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings, and this Commission being otherwise sufficiently advised,

IT IS HEREBY ORDERED that:

1. The motion of the YWCA to intervene is granted.
2. The YWCA shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.


3. Should the YWCA file documents of any kind with the Commission in the course of these proceedings, it shall also serve a copy of said documents on all other parties of record.

Dear Ms. Helton:

The YWCA of Lexington, INC. has received a letter of response from Mr. Sam G. McNamara Attorney at Law for BellSouth Mobility, INC. We are pleased that BellSouth Mobility has agreed to reduce the height of the tower and is proposing other measures that may enhance its appearance. However, our concerns involving health hazards generated from high-voltage equipment and a reduction in the aesthetic character of the residential community have not been fully addressed. In addition, it is our position that a structure of this nature would significantly reduce property value and therefore would be financially detrimental to the YWCA and other surrounding property owners. Mr. McNamara indicated in his June 3, 1998 correspondence that an alternative site is being considered. It is our desire that every measure be taken to avoid the construction of a tower near the YWCA Arnett Pritchett Place, which is a personal licensed care home for 16 elderly women.

Therefore, the YWCA of Lexington is requesting full intervention and a hearing regarding this matter. Our Association has legal representation that would be available to discuss this issue.

We would appreciate hearing from you as to what further steps we should take in this matter.
