O R D E R

Sigma Gas Corporation ("Sigma") has applied for Commission approval to adjust its rates for service rendered on and after June 1, 1998. By this Order, the Commission establishes a procedural schedule for its review of the proposed rate adjustment.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed.
2. All requests for information and responses thereto shall be appropriately indexed and tabbed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.
3. Sigma shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.
4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.

6. Neither opening statements nor witnesses' summaries of prefiled direct testimony will be permitted.


