The City of Owenton, Kentucky ("Owenton") has moved for rehearing on the Commission's Order of September 22, 1998, and to set aside that Order. Owenton has tendered with its motion the prepared direct testimony of its witnesses. Having considered the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted and that a revised procedural schedule should be established.


IT IS THEREFORE ORDERED that:

1. Owenton's Motion for Rehearing is granted.

3. The Order of September 22, 1998 is set aside and vacated.
4. The tendered prepared testimonies of William "Bill" Gill and D. Scott Taylor are accepted for filing.
5. The procedural schedule set forth in the Appendix to this Order shall be followed.
6. All provisions of the Commission's Order of August 14, 1998, that are not in conflict with this Order, shall remain in full force and effect.


7. Pursuant to KRS 278.190(3), the 10-month period for review of Owenton's proposed rate adjustment shall end on February 28, 1999.


