O R D E R

On June 25, 1998, Rhonda Pack filed a motion for full intervention, a request for a hearing, and a petition signed by over 200 customers protesting the proposed rate increase. In addition, Ms. Pack requests to be designated as spokesperson for the protesting customers.

Based on the motion and being otherwise sufficiently advised, the Commission finds that Ms. Pack has a special interest which is not otherwise adequately represented, and that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, her motion to intervene should be granted. The Commission further finds that the request for a hearing is premature. The Commission Staff will investigate the proposed rate increase and issue a Staff Report addressing the merits of the rate increase. Any request for a hearing should be made after the issuance of the Staff Report.

IT IS HEREBY ORDERED that:

1. Rhonda Pack is granted full intervention as an individual and she shall be the spokesperson for the protesting customers.

2. Rhonda Pack shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should Ms. Pack file documents of any kind with the Commission in the course of these proceedings, she shall also serve a copy of said documents on all other parties of record.

4. The request for a hearing is denied as premature, but may be renewed after the issuance of the Staff Report.


