O R D E R

IT IS ORDERED that Kentucky Turnpike Water District ("Kentucky Turnpike") shall file the original and 8 copies of the following information with the Commission by December 29, 1998, with a copy to all parties of record. Each copy of the information requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure its legibility. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this Order.

1. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 3. Kentucky Turnpike's Response to the Commission's Order of October 5, 1998 reflects a combined amortization schedule for Divisions I and II for the 1989 loan from the Kentucky Infrastructure Authority. Provide a schedule that shows the total debt-service requirement of Kentucky Turnpike, Division II only, for each calendar

year from 1998 to 2003. This schedule shall include principal payment, interest payment, and any surcharges, fees or other required payments. This schedule shall also reflect the total requirement while showing a breakdown for each individual debt instrument.

2. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 5. Provide a schedule reflecting total legal expenses incurred during the test year, either itemized by case number or by a general representation service.

3. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 8b. State where in Kentucky Turnpike's Supplemental Responses to Burke's First Information Requests reference is made to the fee of \$15,450.

4. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 9. List all general representation services incurred during 1997 that are not expected to recur.


5. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 18. KRS 74.020(6) provides that the salary of a water district's commissioner "shall be fixed by the county judges/executive with the approval of the fiscal court." How has Kentucky Turnpike determined the salaries paid to its commissioners?

6. Refer to Kentucky Turnpike's Response to the Commission's Order of November 13, 1998, Item 19. Identify the fire departments that receive free water service from Kentucky Turnpike.
