## ORDER

On June 23, 1999, Crown Communication Inc. ("Crown") filed with the Commission a notice of collocation. The notice stated the intention of GTE Wireless of the South ("GTE Wireless") to collocate on the proposed wireless communications facility of Crown. Crown then requested the Commission grant full intervention to GTE Wireless in this proceeding.

On June 23, 1999, Crown also filed with the Commission a motion to request entry of a "standard" prehearing Order. The motion requests the issuance of a procedural Order prior to the hearing scheduled for July 7, 1999.

Crown makes two requests: first, that testimony be limited to the "engineering design, location, and construction of the proposed cell site, as well as the jurisdictional safety issues relating to the cell site," and, second, that all interested parties be allowed

to participate. The topics for testimony are standard for public hearings regarding cellular construction. Thus, Crown's motion will be granted.

In addition, GTE Wireless has a special interest which is not otherwise adequately represented. GTE Wireless's intervention is likely to present issues and develop facts that will assist the Commission without unduly complicating or disrupting the proceedings.

## IT IS THEREFORE ORDERED that:

- 1. GTE Wireless is granted intervention.
- 2. GTE Wireless shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
- 3. Should GTE Wireless file documents of any kind with the Commission in the course of these proceedings, it shall also serve a copy of said documents on all other parties of record.
- 4. Crown shall appear at the hearing and be prepared to present testimony on the engineering design, location, and construction of the proposed cell site, as well as the jurisdictional safety issues relating to the cell site.
- 5. Any interested person shall have the opportunity to present testimony or comment on any aspect of the proposed cell site.
