O R D E R

On March 14, 2001, Hillridge Facilities, Inc. (“Hillridge”) filed an application for a rate increase pursuant to the Alternative Rate Filing procedures in Administrative Regulation 807 KAR 5:076. On August 10, 2001, Hillridge notified its customers of the filed rate case. Since that time, many of Hillridge’s customers have filed requests for intervention in this matter.¹

Most of the customers’ intervention requests are identical and provide no basis for intervention other than as a customer. Administrative Regulation 807 KAR 5:001, Section 8 provides that a person shall request full intervention in writing and “shall specify his interest in the proceeding which is not otherwise adequately represented or that full intervention by party is likely to present issues or to develop facts that assist the commission in fully considering the matter without unduly complicating or disrupting the proceedings[.]” Although most of the requests for intervention fail to state any specific special interest or that each person’s interests are not adequately represented otherwise, the Commission will grant intervention to those who have filed the written request.

¹ The Commission has received approximately 146 requests as of September 28, 2001. Each customer requesting intervention is listed in Appendix A to this Order.

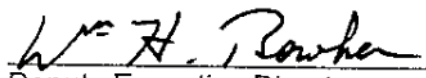
