O R D E R

The Commission, finding good cause, grants Louisville Gas and Electric Company's ("LG&E") motion to amend the procedural schedule in this case. IT IS HEREBY ORDERED that:

1. A formal hearing in this matter shall be held on February 5, 2002 at 9:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, and shall continue until completed.
2. The parties shall meet in an informal conference with Commission Staff on November 26, 2001 at 9:00 a.m., Eastern Standard Time, in Conference Room 2 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
3. On or before December 3, 2001, LG&E/KU shall file with the Commission in verified form the direct testimony of each witness that it expects to call at the formal hearing or any other evidence that the parties plan to introduce at hearing.
4. On or before December 10, 2001, intervenors may serve upon LG&E/KU any supplemental requests for production of documents and written interrogatories.
5. On or before December 21, 2001, LG&E/KU shall file responses to the supplemental requests for production of documents and written interrogatories.

6. On or before January 9, 2002, each intervenor shall file with the Commission in verified form the direct testimony of each witness that it expects to call at the formal hearing or any other evidence that it plans to introduce at hearing.

7. On or before January 14, 2002, LG&E/KU may serve upon intervenors any initial requests for production of documents and written interrogatories to be answered no later than January 23, 2002.

8. On or before January 30, 2002, each party shall file with the Commission in verified form the testimony of each rebuttal witness that it expects to call at the formal hearing.

9. LG&E/KU shall give notice of the hearing in accordance with the provisions of 807 KAR 5:011, Section 8(5).

10. January 14, 2001 shall be the last day for LG&E/KU to publish notice of the hearing date.

11. Direct examination of witnesses shall be limited to the authentication and adoption of written testimony. No summarization of written testimony by the witness shall be permitted.

12. Witnesses who have filed written direct and rebuttal testimony shall present that testimony at the same sitting. Opposing parties may cross-examine such witnesses on both direct and rebuttal testimonies.

13. No opening statements shall be made at the hearing.

14. Within 15 days of the filing of the hearing transcript with the Commission, any party may submit a written brief. Briefs shall not exceed 25 pages in length.

15. Copies of all documents served upon any party shall be served on all other parties and filed with the Commission.

16. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

17. To be timely filed with the Commission, a document must be received by the Secretary of the Commission within the specified time for filing except that any document shall be deemed timely filed if it has been transmitted by United States express mail, or by other recognized mail carriers, with the date the transmitting agency received said document from the sender noted by the transmitting agency on the outside of the container used for transmitting, within the time allowed for filing.

18. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5.02.

19. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
