<u>ORDER</u>

On May 25, 2000, Rattlesnake Ridge Water District (Rattlesnake Ridge) submitted an application for a Certificate of Public Convenience and Necessity to construct, finance, and increase rates for a waterworks improvement project. The application was made pursuant to KRS 278.023, which requires the Commission to accept agreements between water utilities and the U.S. Department of Agriculture (USDA) or the U.S. Department of Housing and Urban Development, and to issue the necessary Orders to implement the terms of such agreements within 30 days of satisfactory completion of the minimum filing requirements. As KRS 278.023 does not grant the Commission any discretionary authority to modify or reject any portion of the agreement, the Commission entered an Order on June 22, 2000, approving Rattlesnake Ridge's application and rate increase.

Rattlesnake Ridge subsequently discovered an inadvertent miscalculation of the amount of the minimum bill for customers with 1½-, 2- and 3-inch meters. The rate schedule for Rattlesnake Ridge also did not include minimum bill amounts for customers with a 4- or 6-inch meter. As required by KRS 278.023, the Commission approved the rate schedule listed in Rattlesnake Ridge's Letter of Conditions from the USDA. On May 3, 2002, the USDA issued an Amended Letter of Conditions to Rattlesnake Ridge that contained the proper rate schedule. On May 20, 2002, Rattlesnake Ridge submitted the Amended Letter of Conditions to the Commission for consideration. On July 29, 2002, Rural Development (RD) of USDA filed a letter, stating that the rates shown in the Amended Letter of Conditions were, in fact, the rates originally intended to be listed in the original Letter of Conditions.

RD and Rattlesnake Ridge have established that the rates included in the original Letter of Conditions and incorporated in the printed rate schedule were based upon incorrect calculations.

IT IS THEREFORE ORDERED that the corrected rates shown in the Appendix attached hereto are approved for service rendered on and after the date of this Order.
