On April 12, 1993, in Case No. 1992-00326, the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. (Equitable), and provided for their further adjustment on a quarterly basis in accordance with Equitable s gas cost adjustment (GCA) clause.

On March 25, 2002, Equitable filed its proposed GCA to be effective May 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected increase in wholesale gas costs. Equitable's expected gas cost (EGC) is \$5.1044 per Mcf, which is an increase of 15.10 cents per Mcf from its previous EGC of \$4.9534.

2. Equitable s notice sets out a current quarter actual adjustment (AA) of 43.80 cents per Mcf to collect under-recovered gas cost from November and December 2001 and January 2002. Equitable s total AA is (23.63) cents per Mcf, which is \$1.0386 per Mcf less than the previous total AA. 3. Equitable s notice sets out a current quarter balancing adjustment (BA) of (.78) cent per Mcf. Equitable s total BA is (2.78) cents per Mcf, which is (.61) cent per Mcf less than the previous total BA.

4. Equitable's GCA is \$4.8403 per Mcf, 89.37 cents per Mcf less than its previous rate of \$5.7340.

5. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for final meter readings by Equitable on and after May 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after May 1, 2002.

2. Within 20 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.

3. Equitable s notice sets out a current quarter balancing adjustment (BA) of (.78) cent per Mcf. Equitable s total BA is (2.78) cents per Mcf, which is (.61) cent per Mcf less than the previous total BA.

4. Equitable's GCA is \$4.8403 per Mcf, 89.37 cents per Mcf less than its previous rate of \$5.7340.

5. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for final meter readings by Equitable on and after May 1, 2002.

1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after May 1, 2002.

2. Within 20 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.
