ORDER

On August 9, 2002, Northern Kentucky Water District (NKWD) moved the Commission for an extension of time to August 19, 2002 to file responses to information requests. NKWD states that it will not be possible for it to complete the responses by August 12, 2002 as required because of the volume of information requested and the resources available to it.

The Commission, having reviewed the motion and being otherwise sufficiently advised, finds that NKWD has shown good cause to allow it additional time to file its responses. The Commission further finds that the procedural schedule established by the Commission in this proceeding should be amended.

IT IS THEREFORE ORDERED that NKWD's motion for extension of time is granted and the procedural schedule established by the Commission in this proceeding is amended as set forth in Appendix A to this Order.
