Commission Staff may serve supplemental
interrogatories and requests for production of documents
upon other parties no later than 08/26/2002

Parties shall file with the Commission and serve upon all parties of
record responses to supplemental interrogatories and requests for
production of documents no later than 09/10/2002

Commission Staff or any party may take the testimony of
any person by deposition upon oral examination pursuant
to notice or by agreement on or until 09/10/2002

Commission Staff shall file with the Commission
and serve upon all parties the direct testimony in written form
of all persons* that it intends to call as witnesses in this matter
no later than 09/17/2002

All parties may serve interrogatories and requests for production
of documents upon other parties and Commission Staff no later than 09/24/2002

Commission Staff and all parties shall file with the Commission
and serve upon all parties of record responses to interrogatories
and requests for production of documents no later than 10/04/2002

Parties may serve supplemental interrogatories and requests
for production of documents upon other parties no later than 10/14/2002

Commission Staff and all parties shall file with the Commission
and serve upon all parties of record responses to supplemental
interrogatories and requests for production of documents no later than..... 10/24/2002

All parties shall file with the Commission
and serve upon other parties a list of the persons who they intend
to testify at the scheduled hearing in this matter and a detailed
summary of their expected testimony no later than 10/30/2002

A hearing shall be held in this matter, in the Commission s offices
at 211 Sower Boulevard, Frankfort, Kentucky to hear testimony..... 11/06/2002
