7. The procedural schedule set forth in Appendix A of this Order modifies and supersedes the procedural schedule set forth in Appendix A of the Commission's Order of September 13, 2002.

8. All provisions of our previous Orders in this proceeding that are not in conflict with the provisions of this Order shall remain in effect.
