4. The procedural schedule set forth in the Commission's Order of July 3, 2002 is replaced with the procedural schedule set forth in Appendix A to this Order.

5. All provisions of the Commission's Orders of June 27, 2002 and July 3, 2002 that are not in conflict with the provisions of this Order shall remain in full force and effect.
