<u>ORDER</u>

On May 31, 2002, Louisville Gas and Electric Company (LG&E) filed with the Commission in Case No. 2000-00548¹ a report on the results of its prepaid meter program that became effective on January 4, 2001. Based on that report, the Commission finds that an investigation should be conducted of that program in a new case. Therefore, we will initiate this case and deem those persons who were intervenors in Case No. 2000-00548 to be parties to this case.

IT IS THEREFORE ORDERED that:

- 1. Those persons who were intervenors in Case No. 2000-00548 shall be parties to this case.
- 2. The procedural schedule set forth in Appendix A, attached hereto and incorporated herein, shall be followed in this proceeding.
- 3. All requests for information and responses thereto shall be appropriately indexed and an original and six copies shall be filed with the Commission and a copy shall be served on all parties.
- 4. Any requests from the Commission Staff for information shall be responded to as if set forth in a Commission Order. All responses should be placed in a

bound volume with each item tabbed. When a number of sheets are required for an

item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6.

Each response shall include the name of the person who will be responsible for

responding to questions relating to the information provided. Careful attention should be

given to copied material to ensure that it is legible. Where the requested information has

been previously provided in the record of this case, reference may be made to the

specific location of the information in responding to the request.

5. LG&E shall give notice of any hearing in accordance with the provisions

set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, LG&E shall

forward a duplicate of the notice and request to the Commission.

6. At any public hearing in this matter, neither opening statements nor

summarization of direct testimony shall be permitted.

7. Motions for extension of time with respect to the schedule herein shall be

made in writing and will be granted only upon a showing of good cause.

8. Nothing contained herein shall prevent the Commission from entering

further Orders in this matter.
