On December 27, 1999, in Case No. 1999-00176, the Commission approved rates for Delta Natural Gas Company, Inc. (Delta) and provided for their further adjustment in accordance with Delta s gas cost adjustment (GCA) clause.

On June 24, 2002, Delta filed its proposed GCA to be effective August 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Delta s expected gas cost (EGC) is \$4.5259 per Mcf, which is 14.86 cents per Mcf less than the previous EGC of \$4.6745.

3. Delta s notice sets out a total refund adjustment (RA) of (2.09) cents per Mcf, which represents no change from the previous total RA.

4. Delta s notice sets out a current quarter actual adjustment (AA) of (10.96) cents per Mcf. The total AA of 26.84 cents per Mcf is 31.26 cents per Mcf more than the previous total AA.

5. Delta s notice sets out a balance adjustment (BA) of 41.68 cents per Mcf, which is 10.56 cents per Mcf more than the previous BA.

6. Delta s GCA is \$5.1902 per Mcf, which is 26.96 cents per Mcf more than the previous GCA of \$4.9206.

7. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for final meter readings by Delta on and after August 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after August 1, 2002.

2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
