## ORDER

On October 10, 1987, in Case No. 9565, the Commission approved rates for Public Gas Company ( Public ) and provided for their further adjustment in accordance with Public s gas cost adjustment ( GCA ) clause.

On July 1, 2002, Public filed its proposed GCA to be effective August 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Public's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Public's proposed expected gas cost (EGC) is \$5.389 per Mcf, which is an increase of 1.50 cents per Mcf from the previous EGC of \$5.374.
  - 3. Public s notice sets out no current quarter refund adjustment.
- 4. Public's notice sets out a current quarter actual adjustment (AA) of (18.17) cents per Mcf to return over-recovered gas costs from February, March and April 2002. Public's total AA is (30.01) cents per Mcf, which is 4.39 cents per Mcf more than the previous total AA.
- 5. Public's GCA is \$5.0889 per Mcf, which is 5.89 cents per Mcf more than the previous GCA of \$5.030.

6. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for gas supplied by Public on and after August 1, 2002.

# IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for gas supplied on and after August 1, 2002.
- 2. Within 20 days of the date of this Order, Public shall file with this Commission its revised tariffs setting out the rates authorized herein.
