<u>O R D E R</u>

On April 12, 1993, in Case No. 1992-00326, the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. (Equitable), and provided for their further adjustment on a quarterly basis in accordance with Equitable s gas cost adjustment (GCA) clause.

On September 23, 2002, Equitable filed its proposed GCA to be effective November 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Equitable s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Equitable s expected gas cost (EGC) is \$6.8161 per Mcf, which is an increase of 33.01 cents per Mcf from its previous EGC of \$6.4860.
- 3. Equitable s notice sets out a current quarter actual adjustment (AA) of 20.81 cents per Mcf to collect under-recovered gas cost from May, June, and July 2002. Equitable s total AA is \$1.1323 per Mcf, which is 29.35 cents per Mcf more than the previous total AA.

4. Equitable s notice sets out a current quarter balancing adjustment (BA) of (13.07) cents per Mcf. Equitable s total BA is 23.84 cents per Mcf, which is 9.80

cents per Mcf less than the previous total BA.

5. Equitable s GCA is \$8.1868 per Mcf, 52.56 cents per Mcf more than its

previous rate of \$7.6612.

6. The rates in the Appendix to this Order are fair, just, and reasonable, in

the public interest, and should be approved for final meter readings by Equitable on and

after November 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order, attached hereto and incorporated

herein, are approved for final meter readings on and after November 1, 2002.

2. Within 20 days of the date of this Order, Equitable shall file with this

Commission its revised tariffs setting out the rates authorized herein.
