On February 16, 1999, in Case No. 1998-00499, the Commission approved rates for Jefferson Gas Transmission Company (Jefferson) and provided for their further adjustment in accordance with Jefferson s gas cost adjustment (GCA) clause.

On October 1, 2002, Jefferson filed its proposed GCA to be effective November 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Jefferson s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Jefferson's proposed expected gas cost (EGC) is \$3.3869 per Mcf, which is \$1.0240 per Mcf more than the previous EGC of \$2.3629.

3. Jefferson s notice sets out no current quarter refund adjustment.

4. Jefferson s notice sets out a current quarter actual adjustment (AA) of (.9) cent per Mcf to return over-recovered gas costs from May, June and July 2002. Jefferson reversed a sign in its calculation of the monthly cost difference for July. Correcting for this error produces a current quarter AA of (1.31) cent per Mcf. Jefferson s total AA is (31.76) cents per Mcf, which is 1.31 cents per Mcf less than the previous total AA.

5. Jefferson s GCA is \$3.0693 per Mcf, which is \$1.0109 cents per Mcf more than the previous GCA of \$2.0584.

6. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for gas supplied by Jefferson on and after November 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for gas supplied by Jefferson on and after November 1, 2002.

2. Within 20 days of the date of this Order, Jefferson shall file with this Commission its revised tariffs setting out the rates authorized herein.
