FIRST DATA REQUEST OF COMMISSION STAFF TO JACKSON PURCHASE ENERGY CORPORATION

Jackson Purchase Energy Corporation (JPEC), pursuant to Administrative Regulation 807 KAR 5:001, is to file with the Commission the original and 8 copies of the following information, with a copy to all parties of record. The information requested herein is due within 10 days of the date of this data request. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information herein has been previously provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

- 1. Provide the computation used in obtaining the \$.32 mileage rate used by JPEC in its cost justifications for those non-recurring charges that require travel.
- 2. Explain the difference in mileage of 15 miles required for a connect or reconnect and 23 miles for an after-hours reconnect or hookup.

- 3. Refer to Exhibit 2, page 4 of JPECs application. The labor required for an after-hours reconnect or hookup is 1.52 hours. The estimated time for a connect or reconnect is .5 hour as shown on page 6 of Exhibit 2. Provide an explanation of the additional 1.02 hour that is required for a connect or reconnect that is performed after-hours.
- 4. In Exhibit 2, page 7 of JPEC s application, Note B to the exhibit states that JPEC will discontinue its current \$15.00 membership fee in conjunction with the inception of its proposed connection charge.
- a. JPECs balance sheet shows that as of June 30, 2002, \$315,985 in memberships was held by JPEC. If memberships are no longer to be required, explain how JPEC proposes to treat the \$315,985 now shown as members equity.
- b. Explain what happens under JPECs current tariff to a members membership fee when the member leaves the JPEC system.
- 5. Refer to Exhibit 2, page 4, Item B of the application. One-half hour of the dispatcher's time is allocated for clerical and office expense related to each. After Hours Charge for Reconnect or Hookup. Provide an explanation of the process that the dispatcher must go through for a reconnect or hookup that requires 30 minutes of his or her time to complete. In your explanation, break down the time required to complete each step of the process.
- 6. Refer to Exhibit 2, page 7, Note C of the application. Explain if the difference refunded to the customer between the \$75.00 deposit and the actual direct charge is reflected in the After Hours Charge revenue. In your explanation, provide the accounting entry that would be required to record such a refund.
