ORDER

On January 31, 2002, in Case No. 2001-00092, the Commission approved rates for The Union Light, Heat and Power Company (ULH&P) and provided for their further adjustment in accordance with ULH&P s gas cost adjustment (GCA) clause.

On October 30, 2002, ULH&P filed its GCA to be effective November 28, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. ULH&P s notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
2. ULH&P s expected gas cost (EGC) is \$5.050 per Mcf, which is an increase of 90.6 cents per Mcf from the previous EGC of \$4.144.
3. ULH&P s notice sets out a current refund adjustment (RA) of .1 cent per Mcf. The total RA of .5 cent per Mcf represents an increase of .5 cent per Mcf from the previous total RA.
4. ULH&P s notice sets out a current actual adjustment (AA) of (9) cents per Mcf. The total AA of (52.1) cents per Mcf is a decrease of 11.7 cents per Mcf from the previous total AA.

5. ULH&P's notice sets out a current balancing adjustment (BA) of 8.8 cents per Mcf. The total BA of 7.1 cents per Mcf is a decrease of 11.6 cents per Mcf from the previous total BA.

6. ULH&P's gas cost recovery rate (GCR) is \$4.595 per Mcf, which is 67.8 cents per Mcf more than its previous GCR of \$3.917.

7. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for final meter readings by ULH&P on and after November 28, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after November 28, 2002.

2. Within 20 days from the date of this Order, ULH&P shall file with this Commission its revised tariffs setting out the rates authorized herein.
