On May 12, 1993, in Case No. 1992-00331, the Commission approved rates for Western Lewis-Rectorville Water and Gas District (Western Lewis) and provided for their further adjustment in accordance with Western Lewiss gas cost adjustment (GCA) clause.

On November 6, 2002, Western Lewis filed its proposed GCA to be effective December 1, 2002. Western Lewis requests a waiver of the 30-day notice period because it did not receive its expected gas rates from its supplier until after November 1, 2002. As KRS 278.180(1) permits the Commission to shorten the required notice period for good cause, the Commission finds the utility s request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western Lewis s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Western Lewis s proposed expected gas cost (EGC) is \$5.3276 per Mcf, which is 5.47 cents per Mcf more than the prior EGC of \$5.2729.

3. Western Lewis s notice sets out no refund adjustment.

4. Western Lewiss notice sets out no current guarter actual adjustment (AA). Western Lewiss notice sets out a total AA of (73.11) cents per Mcf, which represents no change from the previous total AA.

5. Western Lewiss notice sets out no current guarter balance adjustment (BA). Western Lewiss notice sets out a total BA of (6.38) cents per Mcf, which represents no change from the previous total BA.

6. These combined adjustments produce a gas cost recovery rate (GCR) of \$4.5327 per Mcf, which is 5.47 cents per Mcf more than the previous rate of \$4.4780.

7. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for bills rendered by Western Lewis on and after December 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for bills rendered on and after December 1, 2002.

2. Within 20 days of the date of this Order, Western Lewis shall file with this Commission its revised tariffs setting out the rates authorized herein.
