O R D E R

Pursuant to Administrative Regulation 807 KAR 5:056, Section 1(11) and (12), IT IS HEREBY ORDERED that:

1. A public hearing shall be held on February 18, 2003 at 9:00 a.m., Eastern Standard Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Cumberland Valley Electric, Inc. (Cumberland) from November 1, 2000 to October 31, 2002. If no interested party files written notice of its intent to attend this hearing with the Commission by February 13, 2003, this public hearing shall be cancelled.

2. Cumberland shall file with the Commission, on or before January 13, 2003, an affidavit attesting to its compliance or noncompliance with the requirements of Administrative Regulation 807 KAR 5:056.

3. Cumberland shall publish the following notice not less than 7 days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Cumberland shall also file an Affidavit of Publication of Hearing Notice with the Commission when received from the publisher, but no later than February 18, 2003.

A public hearing will be held on Tuesday, February 18, 2003, at 9:00 a.m., Eastern Standard Time, at the offices of the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Cumberland Valley Electric, Inc. for the period November 1, 2000 to October 31, 2002. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than February 13, 2003. If no notices of intent to attend are received by that date, this hearing will be cancelled. Written notice of intent to attend this hearing should be sent to: Thomas M. Dorman, Executive Director, Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.

4. Cumberland shall, on or before January 7, 2003, file with the Commission an original and 5 copies of the information listed in Appendix A. Each copy shall be placed in a bound volume with each item tabbed. When numerous sheets are required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. Cumberland shall furnish with each response the name of the witness who will be available at the public hearing to respond to questions concerning each area of information requested. Cumberland shall ensure that copied material is legible.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 2002-00439 DATED December 11, 2002

1. a. Provide a schedule of the calculation of the 12-month average line loss by month for November 2000 through October 2002.
 - b. Describe the measures that Cumberland has taken to reduce line loss during this period.
2. Provide a schedule showing the calculation of monthly over- or under-recovery of fuel costs from November 1, 2000 through October 31, 2002.
3. Provide Cumberland's monthly revenue reports (monthly billing summaries) showing the total revenue collected, including adjustments under the fuel adjustment clause reported in Cumberland's monthly filings required by the Commission from November 1, 2000 through October 31, 2002.
4. Provide a schedule showing the calculation of the increase or decrease in Cumberland's base fuel costs per KWH as proposed by its wholesale electric supplier adjusted for Cumberland's 12-month average line loss for November 2000 through October 2002.
5. Provide a schedule of the present and proposed rates that Cumberland seeks to change pursuant to Administrative Regulation 807 KAR 5:056 as calculated in Item 4 above, shown in comparative form.
6. Provide a statement showing by cross-outs and italicized inserts all proposed change in rates. A copy of the current tariff may be used.
