O R D E R

On November 21, 2002, those persons whose names appear on the attached sign-in sheet met to discuss current issues in this proceeding. As a result of that meeting, on December 11, 2002, the Kentucky Payphone Association replied to previous comments of ALLTEL Communications, Incorporated ("ALLTEL"), Cincinnati Bell Telephone Company ("Cincinnati Bell"), and BellSouth Telecommunications, Inc. ("BellSouth"). The Commission, being fully advised, HEREBY ORDERS that:

1. By no later than January 21, 2003, ALLTEL, Cincinnati Bell and BellSouth shall reply to the Kentucky Payphone Association's response.
2. By no later than February 5, 2003 any party wishing to appear at a public hearing shall so notify the Commission and shall submit a list of witnesses and summary of testimony to be presented. If no such request is received by February 5, 2003, then this matter shall stand submitted for decision without further proceedings.
