AMENDED ORDER

On December 13, 2002, the Commission issued its Order opening the above-referenced proceeding. Appendix B to that Order contained a request for certain information pertinent to the proceeding, including a comparison of Kentucky Utilities Company's ( KU ) existing base rates and its proposed base rates reflecting the transfer of fuel costs to KU's base rates from its fuel adjustment clause ( FAC ). KU submitted responses to the information request on January 21, 2003. On April 23, 2003, the Commission entered an Order in this proceeding approving the transfer of additional fuel costs from KU's FAC to its base rates.

On July 23, 2003, KU filed a motion to correct the record of this case Nunc Pro Tunc. KU states that it inadvertently omitted special contract rates from its January 21, 2003 response to the Commission's request for information. With its motion, KU filed corrected responses to the request for information that include its special contract rates.

The Commission acknowledges that the omission of special contract rates from KU's response to the request for information resulted in the rates also being omitted from the Commission's April 23, 2003 Order. KU's corrected responses supplement the record and necessitate an Order approving the revised special contract rates.

IT IS THEREFORE ORDERED that:

1. The April 23, 2003 Order issued in this proceeding is amended to include the rates set forth in Appendix A of this Order as the rates to be charged for service provided to KU's special contract customers effective on and after May 1, 2003.
2. All other provisions of the April 23, 2003 Order shall remain in full force and effect.
